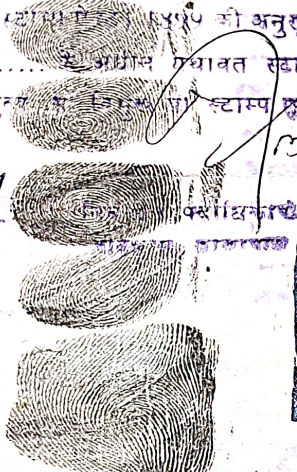

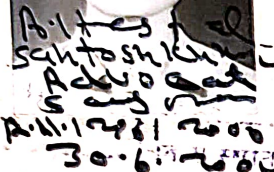

That M/s ABR Foundation merge into ABR Educational Trust with valuation of Rs. 1,56,385 and have no separate intity.

That the president shall chalk programmes for development of the institution for providing better education, appointment and termination of the teaching and non teaching staff, construction of building and other such major jobs, which shall be carried and taken into effect under signature and seal of the Secretary. All policy matters shall be decided by President.

That in the absence of the President, the Vice President shall be incharge of the office of the President and shall discharge all the functions of President including Co-ordination work of the President.

That the treasurer and Secretary shall be responsible for the proper maintenance of A/C and the Book of A/C shall remain in custody of Treasurer and Shall have to be produced for inspection any working day by any member of the committee after obtaining permission from the President of the Trust.

That a general meeting shall be held generally at the first week of the June of every calendar year and shall analyse the development and chalk out programmes for the further development of the Trust. In emeargent circumstances the general meeting can be called and convened at any time.

That the President shall inform at least 7 days prior to the date of meeting.

That the trust committee shall appoint sub committee for the management of the particular institution.

That the trust shall be at liberty to acquire or lease any other undertaking, other trade, business or trust for the benefit of the ABR Educational Trust.

That the Trust shall open account in the name and style of ABR Educational Trust in any nationalized Bank and the A/C shall be operated by the Secretary. No amount can be withdrawn from the A/C without signature and seal of the secretary.

That the secretary is competent to take the loans from any reputed nationalized bank for the development of the trust after the consensus passed by 2/3 majority of vote of executive members.

That the Secretary will look after all the legal matters of the trust.

That the secretary may nominate any persons to look after the legal matters of the trust.

That the secretary can accept the donation in the name of present trust and shall grant a receipt for the same to the donee.

That the secretary will put the signature on receipt bill, appointment letter or any other such valuable documents of the trust.

That vacancy if any caused due to death or resignation of any executive member of the trust, the executive committee can select new members by 2/3 majority of vote.

That in case of any misconduct on the part of any member of the executive committee or sub-committee, the erring member shall be removed from the office by 2/3 majority of vote of the executive members of the Trust.

That the member of the executive committee who devote full time for development of Trust shall be entitled to remuneration as per their ability and devotion which shall be decided by the executive committee.

That the treasurer and Secretary shall be responsible for the proper maintenance

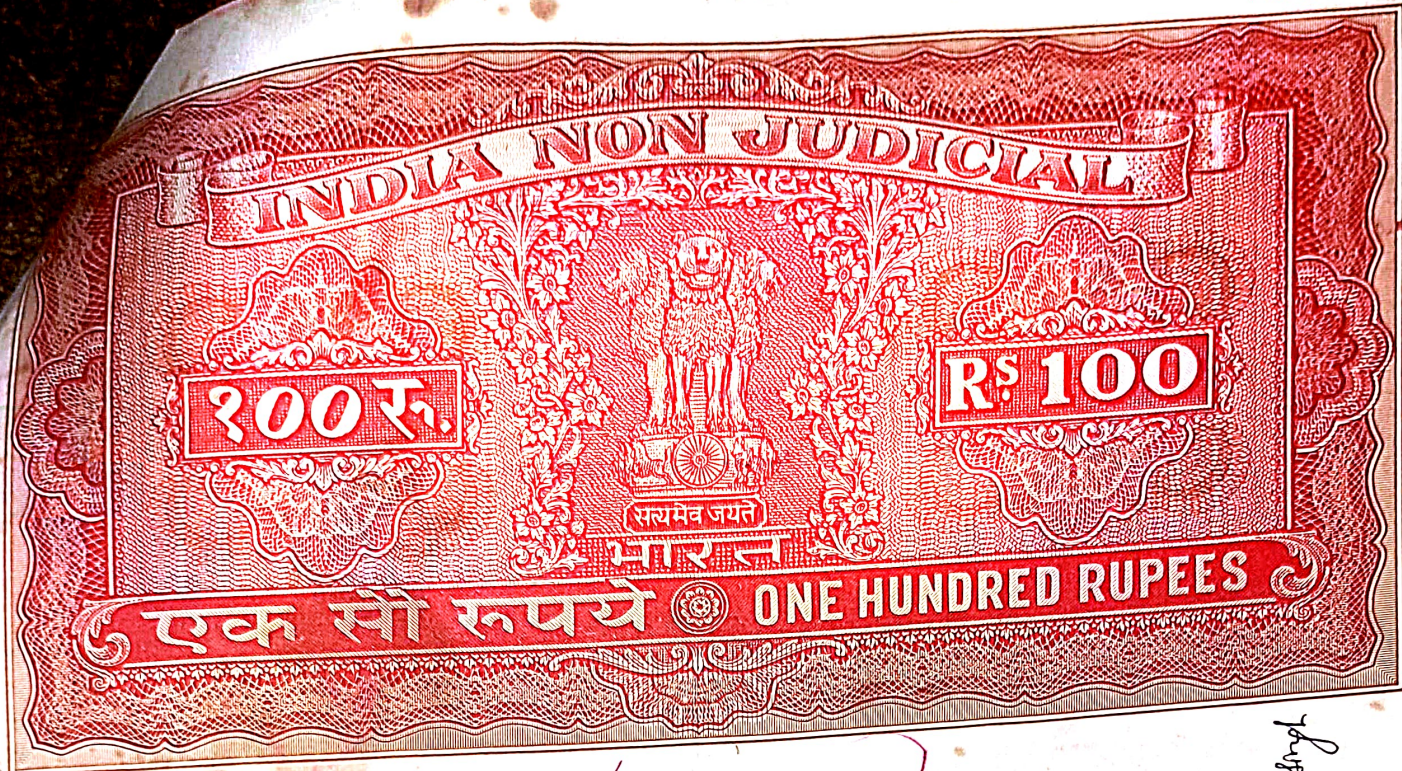
